Participant Updates

Erica with Virginia Health Catalyst shared that they've been engaged with conversations to embed CHWs into the workforce specifically with oral safety net clinics. They want to help CHWs break the glass ceiling and crossover to become dental hygienists. Phyllis Wolf with Corilian Clinic shared they are doing trainings with peer recovery clinic specialists. Leslie Clark with United Way shared that they are moving from a clinical based model to community-based model. They are looking to place CHWs and cross train them. Stephanie Toney with Richmond Henrico Health District shared their CHW virtual training will be coming up on XX date. Pat young from Centra Health shared they are very interested in developing the CHW workforce and want to bring CHWs on

board. Pam Blankenship with VDH shared they offer oral health resources and education to CHWs. She is hopeful to get CHWs into the oral health side of safety net clinics. Robyn Tyler with Central Virginia Health Services shared CVHS has two health workers who set up outreach in schools. Helen Gonzalez of Boston Court Caravan recommends the CHW training that Stephanie Toney mentioned. Lisa Kaplowitz with VDH shared that VDH is bringing on two staff members to coordinate CHW work in the health districts.

Background of CHW Workforce Development Council

Abby Charles spoke on the Development Council and the work that's being done. She shared the current Charter and asked that everyone read it in full to understand the background of the Development Council and spoke on the expected outcomes. Abby spoke on the importance of membership and how joining one of the four committees can be very beneficial to helping create change. **She also discussed that the group will vote to approve the charter at the next development council meeting.**

Service of Recognition

Recognition of Chris Nye who has been with IPHI for the last 6 years helping develop this council. He really pushed this work to make sure CHWs and the CHW workforce were recognized in Virginia. He has transitioned to a new role with VDH. The group shared their kudos and thanks to Chris. Thank you for all the work you've done.

Updates on CHW Certification from the VA Certification Board

Mary Jo Mather gave updates on CHW Certification in Virginia. As of January, the 60 hour training for CHWs must now come from an accredited CHW training program that has been accredited by the VA Certification Board. There are five training providers that have gone through the accreditation process, four of which offer full 60 hours or more, and one that offers partial accreditation. The groups accredited are MHP Salud which offers partial certification, Richmond City Health District, The Blue Ridge Health District, the Institute for Public Health Innovation, and the VA Healthcare Workforce Development Authority are fully accredited. Any training organization is open to apply for accreditation. CHWs have up to a year and a half to complete the recertification process.

Updates on CHWs from Virginia Department of Health

Patrick Wiggins of VDH gave updates on the CDC grant "Living Well" which is ending in 2023. The next iteration of grants may have a greater emphasis on CHWs and on health disparities and how we navigate health equity. VDH is working on Healthy Heart Ambassador Program that trains program facilitators and educators on how to teach others how to take their blood pressure. The goal is to share this with CHWs and the CHW Association to take out into the communities. VA Pharmacists Association is cross-training pharmacy technicians. VDH received a CDC Stroke focused grant and are working with Unite Us to connect stroke patients to CHWs in their communities.

CHW Association Updates

Stephanie Carrington gave updates regarding hiring a new Executive Director for the Association. The Association is reviewing resumes and getting ready for interviews. Their scholarship program has started, where member CHWs who complete a CHW program and who want to become a certified CHW or re-certify can receive funding to pay for their certification. The Association also offers a toolkit for CHWs to help demonstrate to clients how to use tools that help with their chronic diseases. The CHW Association Intake Form:

CHWs for a Healthy VA Update

Valerie McAllister gave updates on the CHWs and COVID Resilient Communities Grant they were awarded in August 2021. This grant has funded 15 implementation sites, and 28 CHWs have been hired for those sites. Through the grant they have established four regional coalitions to address CHWs across VA, and more. The goal of the grant is to build a strong and sustainable workforce in VA.

Virginia CHW Registry

Abby Charles gave an update regarding the CHW registry which is up and running. CHWs can begin registering in the registry. There will be a presentation of the Registry to the Development Council on April 20th at 11am. This will be an opportunity to see how the registry works.
